2019 Item and Scoring Samplers

The Item and Scoring Samplers are useful tools for Pennsylvania educators in preparing local instructional programs by providing samples of test item types and scored student responses. The Item Samplers are not designed to be used as a pretest, a curriculum, or other benchmark for operational testing. The items in the sampler may be used as examples for creating assessment items at the classroom level. Teachers may find it beneficial to have students respond to the text-dependent analysis prompt test questions in the samplers. Educators can then use the samplers as a guide to score the responses either independently or together with colleagues.

NOTE: We have enhanced the annotations associated with the text-dependent analysis score point student responses.

Text Dependent Analysis – Close Reading Lessons

The Text Dependent Analysis (TDA) close reading lessons are designed to be an example pathway for teaching comprehension and analysis of the reading elements **characterization** and **central message**. The Learning Plan guides teachers through the planning and teaching of each lesson, as well as modeling the response to a TDA prompt. The following learning pathway focuses on the text excerpt *Because of Winn Dixie* and the corresponding prompt found in the **Grade 3 Annotated Student Responses Based on the Text Dependent Analysis Learning Progressions**. The lessons are only one possible instructional pathway and teachers should feel free to modify it to meet the sequence of their curriculum, accommodate content previously taught, or to meet their current students' needs.
